PROMPT

Create an ultra-photorealistic character reference image of an adult Brazilian influencer based strictly on the characteristics provided above. The final image must be horizontal, in a 16:9 aspect ratio, and divided into exactly two equal vertical panels.

LEFT PANEL — FULL-BODY VIEW: Show the influencer completely visible from the top of the head to the soles of the feet. Her entire body must remain inside the frame. Do not crop her head, hair, hands, fingers, legs, feet, shoes or clothing. BRAZILIAN APPEARANCE AND NATURAL REALISM: The influencer must look like a real adult Brazilian content creator. Her appearance should feel natural, relatable and authentic to everyday life in Brazil, without stereotypes, caricatures or an overly glamorous fashion-model appearance. Create realistic human details: natural skin texture and visible pores; subtle facial asymmetry; small natural skin variations and imperfections; realistic eyes, teeth, lips and eyebrows; individual hair strands and subtle flyaway hairs; natural hands, fingers, nails and joints; realistic body proportions and anatomy; natural fabric texture, folds and stitching; a subtle and believable facial expression. The

image must look like a real photograph captured with a premium smartphone or professional camera, not like an AI-generated image.

BACKGROUND: Use exactly the background described in the input field. The environment must look realistic and appropriate to everyday Brazilian life. Keep the background clean and visually organized, but not artificial, luxurious or excessively staged. Use the same consistent background and lighting across both panels.

LIGHTING AND CAMERA: Use soft natural daylight with realistic shadows, balanced exposure and authentic Brazilian skin tones. Use a natural photographic perspective with minimal lens distortion. Use the first uploaded image as the exact visual identity of the adult influencer. Use the second uploaded image as the exact product reference. Automatically analyze the product image to understand its category, appearance, materials, possible purpose and visible features.

Preserve the influencer's exact face, age, hairstyle, skin tone, body proportions and clothing throughout the entire video. Preserve the product's exact shape, size, colors, materials, logo, packaging and visible details.

Never invent product functions, technical specifications, discounts, prices, certifications, medical benefits or results that cannot be safely inferred from the uploaded image. All videos must be vertical 9:16, highly realistic and suitable for TikTok Shop. All spoken dialogue must be in natural Brazilian Portuguese with accurate lip synchronization. Movements, hand interactions, facial expressions, blinking, breathing and speech must look completely natural and human. The influencer must physically hold and interact with the product correctly — the product must never float, deform, disappear, change size or pass through her hands. Do not generate subtitles, captions, logos, watermarks or interface elements unless the prompt specifically requests visual space for them.

Create an ultra-realistic TikTok Shop UGC video with a total duration of exactly 8.0 seconds. Use the first uploaded image as the exact identity of the adult Brazilian influencer and the second uploaded image as the exact product reference. The entire action must happen at normal human speed.

Exactly 8.0-second honest product review. Uploaded adult influencer and product.

0-3s

she holds the product and says: *"O ponto positivo é a praticidade."*

3-6s

she demonstrates one simple action.

6-8s

she adds: *"Mas veja se faz sentido pra você."*

Calm, trustworthy tone. Do not invent disadvantages, technical limitations or exaggerated benefits.

47**EU DO PASSADO**

Creative TikTok video, exactly 8.0 seconds. Uploaded adult influencer playing two versions of herself and the exact product.

0-3s

the past version struggles briefly with a simple task.

3-5s

the present version appears holding the product and says:

"Eu precisava ter te mostrado isso."

5-8s

she performs one simple product action.
